## SB 3287 Signed into Law

CRCA Legislative Consultant working to amend

CRCA Lobbyist Margaret Vaughn spearheaded a press conference recently in Springfield urging the governor and lawmakers to amend the new Illinois Safety Advice Liability law (SB 3287) so that worker safety would not be jeopardized.

The press conference was well received by media outlets and the story was picked up by various TV, radio and newspapers throughout the state. She also coordinated a meeting this week with Rep. Michelle Mussman (D-Schaumburg) to discuss modifications to the

new law. She was accompanied by CRCA Member and Joint Apprenticeship Training Center trustee Jay Refuena, Dep. Fire Chief of Schaumburg, Bill Spencer and, the Operating Engineers Local 150 Attorney, Marc Poulos to discuss the far reaching impact that this new law is having on a variety of professions in regards to safety. Margaret and Marc are in the process of drafting an amendment to the new law to present to legislators when the General Assembly reconvenes. CRCA is planning a Springfield legislative reception during the fall veto session to get more exposure at the Illinois Capitol and become better acquainted with their legislators.



Currently SB 3287 mandates that any entity "providing safety advice" to be held liable in a worker's compensation case with the proposal. If SB 3287 is not amended, "Non House" Safety educators may cease providing this valuable education. Not only does this affect Safety Consultants, CRCA, and the CRCA Trade Show, this also reaches to OSHA 10 hour and even Red Cross CPR training. 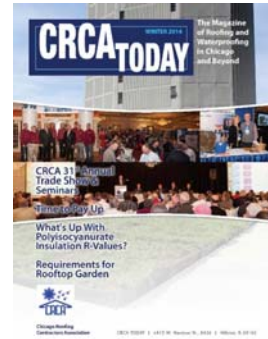
