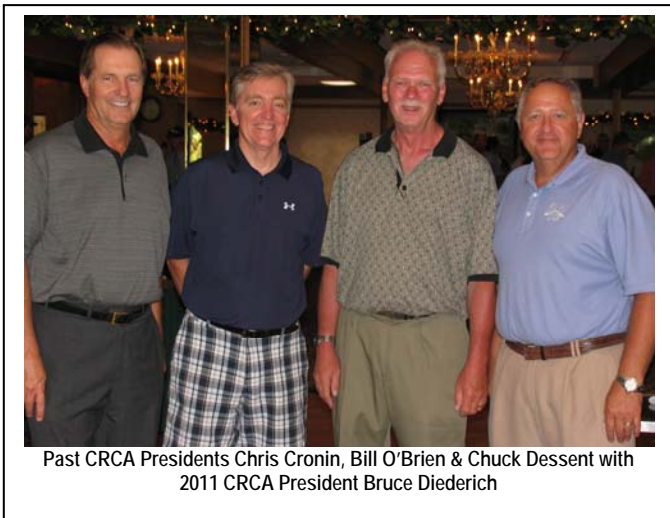

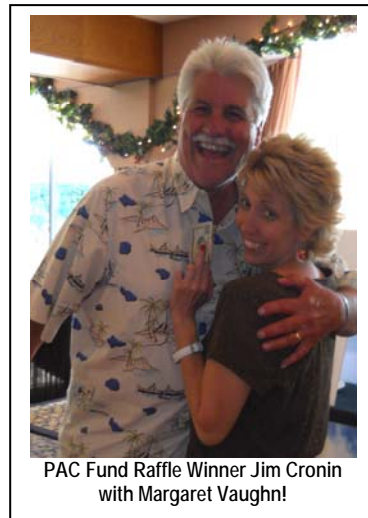

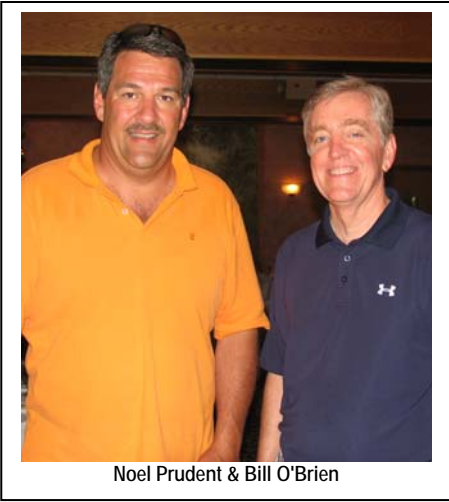

~Legislative Updates

-Gov. Pat Quinn signed legislation on August 2, 2011 that will prohibit roofing contractors from allowing out of state roofing contractors to lease their license numbers for compensation. It also requires roofing contractors to include their license number on all contracts, bids and advertisements. Additionally, the law enables residents to cancel a contract and requires contractors to refund any payments within 10 days of the cancellation. HB 3034 goes into effect January 1, 2012. Senator Wilhelmi stated "This law will prevent contractors from using unscrupulous practices to take advantage of victims and win contracts over more honest competitors."
