**~CRCA offers IDOT Resources** – CRCA roofing contractors report police activity regarding labeling of materials transported to project sites. According to the Illinois State Police, asphalt can be categorized in two different ways, which carry a different label requirement. Below is the link to the site that shows the appropriate classification for asphalt, and other common roofing systems materials. Asphalt can be labeled as class 3 or class 9. Class 3 requires a special drivers license, class 9 does not. Be careful to classify and label appropriately. Here’s the link to the electronic code of federal regulations:

**~NRCA’s Mark Graham at March CRCA Membership Meeting** – Mark Graham spent time with CRCA in March to talk about the new FM Approvals Data Sheet FM 1-29 changes. Mark warned the CRCA Contractors and Associates that the new requirements have significantly increased fastening in the perimeter. Plus, a field uplift test is required as well. ***CRCA suggests that contractors with contracts with FM 1-29 requirements refer to the FM 1-29 standard, version 2004 or earlier in contracts, as this standard has better language.***

~**CRCA Supports NASFM, NRCA at ICC Final Action Code Hearings** – CRCA supported NRCA's Mark Graham at the recent International Code Council International Building Code Hearings. Mark had submitted a code change to add Garden Roofing to the building code. Additionally, we worked with NRCA to support the National Association of State Fire Marshals' proposal to protect heat from metal spreading fire through heat transmission to combustibles below. With support from CRCA, NRCA and NASFM, we were successful getting changes through that are now a part of the 2007 to the 2006 International Building Code. Neither Chicago nor Illinois have adapted the IBC. However, local municipalities have adapted different versions of the IBC, BOCA Standard Building Code, and/or NFPA 101, the Life Safety Code.
